Police Report – Officer Shawn Dent, Cincinnati Police Dept. (CPD)

No report this month.

Fire Report – Cincinnati Fire Dept. (CFD) Lt. Dave Owens

Lt. Owens said that the April run totals were 200, which is pretty typical for the firehouse.

He also stated that the focus area for May will be fire prevention.

- Lt. Owens stated that CFD recently acquired three new fire trucks and one medic truck that are currently being outfitted for service. He said CFD is just starting a recruitment class of 50 people.
- Lt. Owens informed us of the City Alert program through the City of Cincinnati website that allows citizens to sign up to receive alerts of information in their areas as well as the ability to document information helpful to the CFD such as a disabled member in the house or medical conditions that might be helpful on runs.

Clifton Recreation Center (CRC) Report — Brittany Havens

Pres. Goodin introduced Brittany Havens who just was promoted to the role of CRC director for the Clifton Recreation Center.

Ms. Havens stated that she has been working at the Clifton CRC for two and a half years. She thanked CTM for the checks received for the Back to School Bash as well as for a new pottery sink.

She mentioned the 2024 Back to School Bash to be held on August 10. The event will be from noon to 3:00 p.m.. They are looking for additional sponsors for this event.

The Buy Nothing Swap held recently was very successful and will most likely be repeated next year.

Clifton Branch Library — Jeanne Strauss-De Groote

On May 8 there will be an employment program from 3:30 p.m. – 5:30 p.m. for any teenager looking for a summer job.

May 11 will be the annual Lemonade on the Lawn event from 12:00-3:00 p.m. This is an annual outdoor Health and Wellness Fair on the Clifton library lawn. Partners from health organizations such as Caracole, and Hamilton County Public Health, will be providing resources on LGBTQIA plus related health and wellness topics for all ages and identities.

May 18 will be the second annual Plant Fest. There will be games for children and information on composting and sustainable gardening practices from the University of Cincinnati Horticulture Club and Civic Garden Center.

May 29 will be an Introduction to Tai Chi. This event (as are all the others) is free to the public.

Treasurer Report – Gerald Checco

Gerald Checco stated that the budget quarterly review was completed a couple of weeks ago. Attending were Gerald as current Treasurer, Tim Noonan as past Treasurer, John Whedon representing the Golf Outing, Mindi Rich as CTM VP, Joyce Rich representing the Off Ludlow Gallery, Jan Checco representing the Chronicle and the Treasurer of Clifton Soccer. The takeaway from the review was the need to improve procedures for Clifton Soccer payments. That process is underway.

Mr. Checco reported that we have received the Neighborhood Support Program (NSP) grant money of \$7,500. Checks have already been distributed to Clifton Cultural Arts Center for support of the Clifton House Tour and their children's programming, and to CRC.

Mr. Checco reported that Clifton Community Fund has a new project to give grants to businesses to improve their signage and help the signs conform to the

current code. Gerald presented a motion to have CTM vote on whether this new project is in the best interest of CTM. Barry Gee seconded. Passed U.

Miscellaneous Business Updates — Steve Goodin

Steve Goodin mentioned that FD Harper has resigned from the CTM board. CTM now has two openings for trustees.

Pres. Goodin also mentioned the new record store is open in the Torn Light space. Feel It Records has a well curated collection of all types of music as well as a small thrift store section and a live music space.

Clifton Golf Outing — John Whedon

John Whedon said the Golf Outing has raised over \$120,000 for various Clifton beneficiaries. The event hopes to net \$20,000 this year and the beneficiary for this year is Keep Cincinnati Beautiful. John introduced the Keep Cincinnati Beautiful (KCB) Development Director, Samantha Shattuck.

Ms. Shattuck stated that she was a Clifton resident for five years previously. She said that some of the proceeds will be used to produce signs for both Clifton and surrounding neighborhoods to help encourage proper disposal of litter. She also lauded the public art we have in Cincinnati and in particular the Cincinnati is Beautiful mural you can see as you drive by the Hopple Street exit off I-75. The mural needs some TLC, and this may be redone as part of the proceeds of the Golf Outing. Another opportunity she cited was a program called Adopt-A-Spot where community members or businesses adopt a location and agree to keep this litter free. They currently do not have any Gaslight locations in the program. John Whedon had the idea of trying to involve children in the anti-litter effort.

Gerald Checco asked if KCB has thought of partnering with Cincinnati State which has a horticultural and groundskeeping program. Ms. Shattuck responded that they are currently partnering with Cincinnati State in their Workforce Development program.

John Whedon asked for help from the CTM Board in securing sponsors for the Golf Outing.







Apology letter drafted by Rachel Wells

Dear Councilmember Harris,

It is with great regret that we, the trustees of Clifton Town Meeting (CTM), write to you following the May 1, 2024 special meeting of CTM featuring the Connected Communities proposals, to formally apologize for our failure to anticipate and control certain audience members' unreasonable behaviors as you sought to answer the community's questions. The outbursts from the audience were disrespectful and unacceptable.

We intended the meeting to serve as an informational experience for the Clifton community and were grateful that you had agreed to attend to share the intent behind the proposals and highlight how they would affect Clifton. As a community council board, we value your experience and knowledge of budget, finance and housing access and affordability issues. We commend you for proactively seeking solutions and challenging the city to carefully examine how zoning and land use policies have contributed to our current housing crisis as well as ongoing disparities of outcomes in our city.

While we intend to further explore some concerns that residents have raised, we recognize that the attendees at the May 1 special meeting were not representative of our community, the majority of which rent their homes. As CTM takes a closer look at the Connected Communities policy proposals, we resolve to seek input from a more representative group of residents to better understand how we as a community can best manage change.

Through the meeting you showed enormous patience and grace, setting an example for us all. Thank you for your time, expertise and commitment to public service.
