Speaker from Cincinnati Police (CPD) Capt. Mark Burns, Commander of District 4

Capt. Burns stated that District 4 will assume responsibility for Clifton this Sunday. He said that the current neighborhoods in District 4 are experiencing the same issue facing Clifton. He suggested that we should meet with the District Four Neighborhood Liaison Sergeant Jeffrey Meister. He said that he is looking forward to collaborating with us.

October Meeting Minutes — Justin Ogilby submits motion to approve October meeting minutes, Genet Singh seconds (U).

Treasurer's Report / bi-annual review – Tim Noonan.

Reports for October currently in progress. Will be done by the end of the week. For the bi-annual financial review, he has been meeting with the current treasurer of the Clifton Community Fund. The main recommendation so far has been to consider grants as a liability and not on the income side and then pay expenses on that grant.

Introduction of Ballot Initiative - Open Vote

From November CTM Agenda: All Clifton Residents can vote. Nonmembers need to vote in person to verify residency. Non-resident business owners or property owners are not eligible to vote in this special ballot. A vote "No" on this initiative will prohibit non-resident business owners from voting or to be a CTM board member.

Speaker: Malcom Montgomery – Malcolm served on bylaws committee for 6 years. He served as chairperson of that committee. He disapproves of the amendment because it would give people that do not live in the neighborhood the same voting power as those that do. He stressed that the mission of CTM is to be the resident's voice on city matters. He said that business interests are represented already by the Clifton Business Association. He said trustees need to be able to deal with a controversial issue and stand up and take a voice. For that person who has a business interest if you are in that position, you will simply advocate for that community.

Gerald Checco added clarification on this ballot initiative. He said a no vote means that you do not want business owners that are not residents to become trustees or to vote on anything. Just want to give you a little bit of background CTM has about 400 members. That is one of the largest memberships of any Cincinnati neighborhood council. Although it is a substantial number, it is only less than 5% of the total number of people living in Clifton. At least 400 members we only have two members that are businesses but non-residents in Clifton. A yes vote is to give the right of vote for the members that are businesses but non-residents.

Ballot Initiative vote open 7:17 to 7:24 – closed.

Police Report – Officer Shawn Dent, Cincinnati Police Dept. (CPD)

Officer Dent cautioned that CPD normally sees an uptick in crime during December. We need to be vigilant over holidays. He said residents should report all crimes to the police and stay active in neighborhood chat groups to stay aware of crime activities in your area. You can log on to Cincy Insights as well. He also suggested that to deter package thefts we should consider alternative drop

addresses such as Amazon lockers. Residents should make sure that cameras such as Ring cameras should be fully charged.

Introduction of Proposed Bylaws Amendments

Speaker – Malcolm Montgomery – He said that he understands that the work done by the board takes a lot of time and can be a thankless job. He feels that while some of the changes have merit, the overall thrust of the amendments is to concentrate power in a smaller group. Examples he gave of that include not having treasurers report reviewed by outside auditor, email voting, cancelling live meetings. He does not feel that proper deliberations will occur over email. He is concerned some of these amendments may violate state law and open up CTM to lawsuits. He urges a no vote on the amendments.

Geral Checco reviewed each of these items up for vote:

Item A – removes the word full because it relates to full membership and full membership does not exist for all members. This is a grammatical mistake.

Item B – The committee recommends that lifetime rights be removed if a member no longer lives in Clifton.

Item C – The annual meeting will include the election of trustees.

Item D – This amendment would require that at least 45 members vote on any ballot initiative to be a valid vote.

Item E – Same as item D.

Item F – The amendment would reduce the number of trustees from 15 to 11.

Item G – This item would allow the board to not fill trustee vacancies if it is less than 6 months before the election.

Item H – This amendment would allow for the cancellation of a CTM monthly board meeting if two-thirds of trustees vote to cancel.

Item I – This item is a correction of an incorrect Ohio Revised Code reference.

Item J – This amendment proposes the creation of an independent committee to review finances every two years instead of using an independent professional.

Item K – This item would allow business owners (non-resident) to be on the CTM board (up to 2 per board).

Item L – This amendment would allow the annual Nominating Committee report to be given orally as part of Clifton Town Meeting (CTM) board meeting.

Item M – This item would require that a trustee be part of every CTM committee.

Item N – This amendment would establish a CTM finance committee.

Vote on bylaws from 7:34 – 7:59 closed

Joe Brunner is proctoring the election.

Fire Report – Cincinnati Fire Dept. (CFD) Eric Horn

Capt. Horn brought a handout of Thanksgiving fire safety. Cautioned everyone to check their smoke detectors. Detectors should be placed near all sleeping areas and kitchen detectors should not be too close to the stove.

Leslie Mooney – thanked the fire department for assistance during a recent car crash that she had with 2 kids in the car.





35 individuals became members at the November 6 meeting.







Thanksgiving is the peak day for home cooking fires with more than three times the daily average for such incidents.


Cooking causes half of all reported home fires and more than two of every five home fire injuries, and it is the second leading cause of home fire deaths.

Thanksgiving Safety

- Stay in the home when cooking your turkey and check on it frequently.
- Stay in the kitchen when you are cooking on the stovetop.

- Make sure kids stay away from hot food and liquids.
- Keep the floor clear so you don't trip over anything.
- Make sure your smoke alarms are working. Test them by pushing the test button.

Use extreme caution when using Turkey Fryers that contain cooking oil. Consider purchasing an infrared, air fryer, or electric turkey fryer, that has been listed by a qualified testing agency!
